Axpet[®] solid sheets Compliance with EU Directives on hazardous substances

Axpet[®] solid sheets comply with the requirements of:

have not been intentionally added for the production of Axpet[®] sheets.

Therefore these substances are not expected to be present above the regulated thresholds.

The presence of analytically detectable traces far below the limits of the above mentioned substances or compounds containing these substances cannot be excluded.
